**Benefits:** the intended benefits of this procedure/treatment are:

- To treat kidney cancer or ureteric cancer

**Risks: Common**

- Temporary insertion of a bladder catheter and wound drain

**Occasional**

- Bleeding requiring further surgery or transfusions
- Recurrence of disease elsewhere in urinary tract
- Entry into lung cavity requiring insertion of temporary drainage tube
- Need for further therapy for cancer

**Very rare**

- Anaesthetic or cardiovascular problems possibly requiring intensive care admission (including chest infection, pulmonary embolus, stroke, deep vein thrombosis, heart attack and death)
- Infection, pain or bulging of incision site requiring further treatment
- Involvement or injury to nearby structures – blood vessels, spleen, liver, lung, pancreas and bowel requiring more extensive surgery
- Very rarely may be a histological abnormality other than cancer

**Alternatives:** I have also discussed what the procedure is likely to involve and any concerns of this patient. I have also discussed having no treatment and the following alternatives:

- Observation
- Radiotherapy, Chemotherapy
- Laparoscopic approach

- I understand that any procedure in addition to those described on this form will only be carried out if it is necessary to save my life or to prevent serious harm to my health.
- I agree that any tissue removed and the results of diagnostic tests may be used for teaching, audit and research that could benefit other patients.
- I have been told about additional procedures, which may become necessary during my treatment. I have listed below any procedures, which I do not wish to be carried out without further discussion.
